SPECIAL INSTRUCTIONS TO BIDDERS (SI)

SI01 Integrity Provisions

As applicable, pursuant to GI01 of the Declaration of Convicted Offences, paragraph 10 (copied below) of the General Instructions **R2710T**, the Bidder must provide with its bid, a completed <u>Declaration Form</u>, to be given further consideration in the procurement process.

Declaration of Convicted Offences

Where a Bidder or its Affiliate is unable to certify that it has not been convicted of any of the offences referenced under the Canadian Offences Resulting in Legal Incapacity, the Canadian Offences and the Foreign Offences subsections, the Bidder must provide with its bid the completed <u>Declaration Form</u>, to be given further consideration in the procurement process.

- 1. Enquiries regarding this bid must be submitted in writing to the Contracting Officer named on the Invitation to Tender Page 1 as early as possible within the solicitation period. Except for the approval of alternative materials as described in GI15 of R2710T, enquiries should be received no later than <u>five (5)</u> calendar days prior to the date set for solicitation closing to allow sufficient time to provide a response. Enquiries received after that time may not result in an answer being provided.
- 2. To ensure consistency and quality of the information provided to Bidders, the Contracting Officer shall examine the content of the enquiry and shall decide whether or not to issue an amendment.
- All enquiries and other communications related to this bid sent throughout the solicitation period are to be directed ONLY to the Contracting Officer named on the Invitation to Tender – Page 1. Failure to comply with this requirement may result in the bid being declared non-responsive.

SI04 Optional Site Visit

There will be a optional site visit on <u>March 4, 2016</u> at <u>11:00 a.m</u>. Interested Bidders are to meet at <u>NRCan's Great</u> <u>Lakes Forestry Centre</u>, located at <u>1219 Queen Street East, Sault Ste. Marie, Ontario, P6A 2E5</u>.

The site visit for this project is optional. Bidders are requested to communicate with the Contracting Authority no later than <u>two (2)</u> business day(s) before the scheduled visit to confirm attendance and provide the names of the person(s) who will attend. The representative of the Bidder will be required to sign the Site Visit Attendance Sheet at the site visit.

SI05 Revision of Bid

SIO6 Bid Results

SI07 Insufficient Funding

In the event that the lowest compliant bid exceeds the amount of funding allocated for the Work, Canada in its sole discretion may:

- a) Cancel the solicitation; or
- b) Obtain additional funding and award the Contract to the Bidder submitting the lowest compliant bid; and/or
- c) Negotiate a reduction in the bid price and/or scope of work of not more than 15% with the Bidder submitting the lowest compliant bid. Should an agreement satisfactory to Canada not be reached, Canada shall exercise option a) or b).

SI08 Bid Validity Period

- Canada reserves the right to seek an extension to the bid validity period prescribed at BA04 of the Bid and Acceptance Form. Upon notification in writing from Canada, Bidders shall have the option to either accept or reject the proposed extension.
- 2. If the extension referred to in paragraph 1 of SIO7 is accepted, in writing, by all those who submitted bids, then Canada shall continue immediately with the evaluation of the bids and its approved processes.
- 3. If the extension referred to in paragraph 1 of SI07 is not accepted, in writing, by all those who submitted bids then Canada shall, at its sole discretion, either
 - a) Continue to evaluate the bids of those who have accepted the proposed extension and seek the necessary approvals; or



- b) Cancel the invitation to tender.
- 4. The provisions expressed herein do not in any manner limit Canada's right in law or under GI11 of R2710T.

SC01 Security Requirements, Document Safeguarding Location

SC02 Insurance Terms

- 1. Insurance Contracts
 - (a) The Contractor must, at the Contractor's expense, obtain and maintain insurance contracts in accordance with the requirements of the Certificate of Insurance. Coverage must be placed with an Insurer licensed to carry out business in Canada.
 - (b) Compliance with the insurance requirements does not release the Contractor from or reduce its liability under the Contract. The Contractor is responsible for deciding if additional insurance coverage is necessary to fulfill its obligation under the Contract and to ensure compliance with any applicable law. Any additional insurance coverage is at the Contractor's expense, and for its own benefit and protection.
- 2. Period of Insurance
 - (a) The policies required in the Certificate of Insurance must be in force from the date of contract award and be maintained throughout the duration of the Contract.
 - (b) The Contractor must be responsible to provide and maintain coverage for Products/Completed Operations hazards on its Commercial General Liability insurance policy, for a period of six (6) years beyond the date of the Certificate of Substantial Performance.
- 3. Proof of Insurance
 - (a) Before commencement of the Work, and no later than thirty (30) days after acceptance of its bid, the Contractor must deposit with Canada a Certificate of Insurance on the form attached herein, at Annex "A".
 - (b) Upon request by Canada, the Contractor must provide originals or certified true copies of all contracts of insurance maintained by the Contractor pursuant to the Certificate of Insurance.
- 4. Insurance Proceeds

In the event of a claim, the Contractor must, without delay, do such things and execute such documents as are necessary to effect payment of the proceeds.


5. Deductible



ANNEX "A" – STATEMENT OF REQUIREMENT

1. Background

The existing 32 ft. (9.75 m) x 22 ft. (6.7 m) Building G Greenhouse must be converted to a new construction, one storey, one bay, air conditioned storage building as per the attached drawings.

2. Description of Requirements

The Work for this Contract comprises of the partial demolition of the existing Building G westerly greenhouse, leaving the concrete knee wall and slab. Followed by, the complete erection, mechanical systems, foundation and site work involved in the installation of a fully functional building at the Great Lakes Forestry Centre, 1219 Queen Street East, Sault Ste. Marie, Ontario, P6A 2E5.

3. Codes and Standards

The Contractor must ensure that all work is completed using all applicable current Canadian and Ontario codes, standards and current best practices.

All Canada Occupational Health & Safety Regulations (SOR/86-304) apply at this facility.

4. Construction

The construction of this project is scheduled to begin Mid-March 2016 with hopes of having the majority of the work completed by **March 31, 2016;** the remaining work shall be in the new fiscal year, with an anticipated end date of **May 31, 2016.**



Canada

The insurance policies required on page 1 of the Certificate of Insurance must be in force and must include the insurance coverage listed under the corresponding type of insurance on this page.

The policies must insure the Contractor and must include Her Majesty the Queen in Right of Canada as represented by the Minister of Public Works and Government Services as an additional Insured.

The insurance policies must be endorsed to provide Canada with not less than thirty (30) day's notice in writing in advance of a cancellation of insurance or any reduction in coverage.

WITHOUT INCREASING THE LIMIT OF LIABILITY, THE POLICIES MUST PROTECT ALL INSURED PARTIES TO THE FULL EXTENT OF COVERAGE PROVIDED. FURTHER, THE POLICIES MUST APPLY TO EACH INSURED IN THE SAME MANNER AND TO THE SAME EXTENT AS IF A SEPARATE POLICY HAD BEEN ISSUED TO EACH.

COMMERCIAL GENERAL LIABILITY

The insurance coverage provided must not be substantially less than that provided by the latest edition of IBC Form 2100.

The policy must either include or be endorsed to include coverage for the following exposures or hazards if the Work is subject thereto:

- (a) Blasting.
- (b) Pile driving and caisson work.
- (c) Underpinning.
- (d) Removal or weakening of support of any structure or land whether such support be natural or otherwise if the work is performed by the insured contractor.

The policy must have the following minimum limits:

- (a) \$5,000,000 Each Occurrence Limit;
- (b) \$10,000,000 General Aggregate Limit per policy year if the policy contains a General Aggregate; and
- (c) **\$5,000,000** Products/Completed Operations Aggregate Limit.

Umbrella or excess liability insurance may be used to achieve the required limits.
