This amendment is raised to provide clarifications and an updated version of the Attachment 4.1 Bid Evaluation Criteria including all Workstreams as indicated in Answer 1 of Amendment 014:

ATTACHMENT 4.1 BID EVALUATION CRITERIA

Technical Evaluation:

The proposal will be evaluated and scored in accordance with the following evaluation mandatory and rated technical criteria.

It is imperative that the proposal addresses the mandatory corporate criteria for each Workstream as well as the mandatory criteria for each Core resource per Workstream, and demonstrates that the requirements are met. All information required to demonstrate that the criteria are met must be part of the bid at bid closing.

Although Bidders can submit a bid that covers more than one Workstream, each Workstream will be evaluated individually and one contract will be awarded per Workstream.

For the bid, wherever degrees, diplomas and/or certifications are required for the Core categories, bidders must include copies of the required documents (or official transcripts) in their bid by the closing date.

For resources that are required post-contract award, for both Core and non-Core categories, the Technical Authority may also request copies of diplomas, degrees and/or certifications with the proposed resources CVs to validate their education.

QUESTIONS AND ANSWERS:

Q1. Updated version: Amendment #12 failed to include the updated version of Bid Evaluation Criteria for Workstream 3. Is it the Crown's intent to post the updated documents for Stream 3?

A1. Canada will provide an updated version of the Attachment 4.1 Bid Evaluation Criteria including Workstream III attached with this amendment 014. Bidders must and are responsible to read it in parallel with all amendments and Q&As posted. The updates with this amendment are provided in red track changes.

Q2. Correction to Amendment 011, Q21. Workstream II National Security Portfolio Experience:

It is difficult to understand the importance that the Crown is placing on National Security Portfolio experience. There appears to be no consistency as to the amount or type of experience that is being asked for, ranging from no experience requirements for the C.15 Computer Forensic Specialist to for the P.5 Project Executive 20 out of the 30 available rated requirements points (66.66%) awarded for National Security Portfolio experience.

It is interesting to note that the National Security Portfolio experience requirements for **P.5 Project Executive** are not related to being a Project Executive on a National Security Portfolio project, but for being a Project Manager.

P.4 Organizational Development Consultant's rated requirements include 33.33% of National Security Portfolio experience and it is for experience that does not appear to be related to Organizational Development.

It is further bewildering that for the **P.9 Project Manager** that it is mandatory that they managed one National Security Portfolio project with no available points for managing additional National Security Portfolio projects.

Would the Crown:

- provide some consistency as to how they value and rate National Security Portfolio project experience across the related positions, and;
- only rate National Security Portfolio experience that is related to the specific category for which the points have been allocated?

A2. Correction to Amendment 011 Q&As in red. **A21. P.5 Project Executive:** Please see RFP modifications #009. **P.4 Organizational Development Consultant:** Please see RFP modifications #012 for updated Bid Evaluation Criteria. **P.9 Project Manager:** Canada is not prepared to revise other aspects of these criteria.

Q4. Correction to Amendment 011, Q35. For Stream 2, P.5 Project Executive, Level 3, for R2:

The Canada Revenue Agency was known as the Canada Customs and Revenue Agency (CCRA) until a federal government reorganization in December 2003, when customs enforcement was moved into the Canada Border Services Agency, which is part of the Public Safety Canada portfolio. Given that the Crown is looking for 10 years within the last 15 years, of experience within the National Security Portfolio,

would a project at the Canada Customs and Revenue Agency (CCRA) in 2003, prior to the split of the department, count as being within the National Security Portfolio?

A4. Correction to Amendment 011 Q&As in red. **A35.** Yes, Canada will accept Canada Customs and Revenue Agency (CCRA) projects directly related to the current mandate of CBSA. Please see RFP modifications #014 for updated Bid Evaluation Criteria.
