SOLICITATION AMENDMENT 002

This amendment is raised to answer Bidders' questions 1 – 6

QUESTIONS AND ANSWERS

Q1	Section 1.2 mentions “human waste barrels”. Can you please clarify what these are, exactly?
A1	These are 40 Gal Drums that are placed in severely remote areas of the training area (approx. 625 Sq KM) in which the soldier places the bags used to collect their human waste. They need to be placed, picked up and the contents disposed of. The barrels must then be cleaned and stored, or replaced into the training area.
Q2	<p>In 4.6 of the General Instructions of the Statement of Work, Annex “A”, it states that during military exercises contractors are seen as ISAF players and may be delayed or detained from necessary work and as such need to be compensated.” Is this expected to be a frequent occurrence, and what are the expected delay times should this occur?</p> <p>2B) Can you please clarify that the “waiting time” listed in point 16 of the basis of payment would be the compensation applied to these types of delays?</p>
A2	This could be a regular occurrence during the peak exercise months of May – July. The contractor could be delayed 15 minutes to half hour. Yes, the waiting time would be compensated for these types of delays as well as if they have to wait to cross the runway or apron for flight operations.
Q3	Section 7.1 of the General Instructions of the Statement of Work, Annex “A”, requires contractors to have an operator and trailer for each vehicle. What type of trailer is this referring to?
A3	It is a delivery trailer for the portable toilets, usually the truck has the vacuum equipment and the trailer carries replacement or additional units.
Q4	Section 7.3 of the General Instructions of the Statement of Work, Annex “A”, states that contractors should have 4 wheel drive capability. Is this a mandatory requirement, or are proponents permitted to have service vehicles without 4 wheel drive provided they understand the onus remains on themselves to rectify the situation should any vehicle get stuck?
A4	Some areas of the training are very rough; specifically the placement of Human Waste Barrels and toilets requires the navigation of our black tracks in often inclement weather. If the vehicle they are sending does not have 4x4 capabilities they will not be able to get to the delivery point, as I said it is a 625 Sq KM area. It would be difficult for a civilian recovery vehicle to get into the area and we cannot have the access routes blocked as this will affect training. it is a definite requirement.
Q5	Section 5 of the Environmental Protection of the Statement of Work, Annex “A”, details cleaning requirements for vehicles that travel off the main service routes. Is this section applicable to this particular RFSO, or more directly, will travel off the Main Service Routes be expected to occur in the completion of the services under this RFSO?

A5	The train area is infected with Knapp Weed and harmful species of plant harmful to cattle, if vehicles stay on our gravel roads they do not need to be cleaned. However if they leave the roads which this contractor will have to often do, they must have the vehicles cleaned to control the spread of the Harmful weed.
Q6	Just to ensure we are pricing correctly, when listing waiting times in point 16 of the basis of payment proponents are expected to enter a per hour charge?
A6	Yes (hourly rate divided by 4 gives you the 15 minute charge)
