This solicitation amendment 001 is issued to answer questions raised by the industry.

Q1. Is the contractor responsible for replacing the plastic bag / paper bag liners for the organics bins after each pick up?

R1. No, the contractor is not responsible for replacing the plastic bag/paper bag liners for the organics bins after each pick-up.

Q2. Can the contractor be granted a site visit for the compactor at L'esplenade Laurier?

R2. Arrangements can be made with the contractor who wins the contract to have a site visit. The compactor in question is 30 cubic yards.

Q3. The total units listed on the Pricing Schedule 2, do not match the summary of bins on the mast site lists?

R3. It is indicated in Annex B Collection Locations, Containers and Schedule Requirement which is the master site that "due to the nature of this requirement, these lists may change during the solicitation process", therefore use pricing schedule in Annex C to submit your financial offer.

Q4. Are you able to provide average weights for the compost containers and pulverized paper?

R4. We are not able to provide average weights for the compost containers and pulverized paper.

Q5. Are you able to provide average weights for loose waste bag collection? What is the max weight allowed per bag?

R5. We are not able to provide average weight for loose waste bag collection? There is currently no max weight per bag established.

Q6. A 6yd front load container for pulverized paper is listed under the organics collection section at Skyline on Baseline. Does this material need to be collected as compost? We are not aware of a dedicated compost collection service using front load vehicles.

R6. Yes, pulverized paper needs to be collected as compost.

Q7. Is there any flexibility with collection times, particularly in the downtown area ie. the Parliamentary Precinct.

R7. There are no flexibilities on collection times, particularly with Parliamentary Precinct.

Q8. Do any of the stops listed require a winch to pull out front load containers?

R8. To the best of our knowledge a winch is not required to pull out front load containers.

Q9. Is there any flexibility with moving service days for sites that require 1-2 pickups per week?

R9. There is limited flexibility on moving service days for sites. It will need to be discussed on a site per site bases after the contract is awarded and the client would get final approval.
