DESCRIPTION:

ANSWERING QUESTIONS FROM POTENTIAL BIDDERS FOLLOWING THE SITE VISIT.

1. The Provincial Government is putting in effect the Seasonal Weight Restrictions tomorrow (March 2, 2016) New Brunswick and Nova Scotia are in place already. This means we can't haul full loads of gravel.

Commence the work when the restrictions are removed.

- 2. There may be no need to stockpile the gravel when the restrictions are removed, the gravel may be able to be spread directly on the roads if the sewer and water lines are in place.
- 3. Complete gravel work by June 3 (Terms of Reference stated June 1)
- 4. Campsite driveways are 10' wide (no pad included)
- Roadway widths varies in the campground (some roads are 2-way and others are 1-way)
- 6. Campsite driveways will be graded by others.
- 7. Contractors wanted a site plan to show new campsites and roads.
- 8. The use of an Asphalt Spreader for the laying the gravel on the campsite driveways and roadway would be suggested.
- 9. See attached site plan to show new campsites and roads.
- 10. Bid Security Requirements R2710T is incorporated by reference and is set out in the Standard Acquisition Clauses and Conditions (SACC) Manual, issued by Public Works and Government Services Canada (PWGSC).
