This amendment No. 003 is raised to address questions regarding Solicitation W0134-16R022/A as follows:

PART A: QUESTIONS AND ANSWERS

- Q1.** Part 5--Certifications and Additional Information, Page 4: CSA Certification: All StingRay Parts Washers meet Canadian and American electrical codes yet we do not provide a third party certification unless specifically requested. Reading the specification B1501C it states the equipment should be certified by a certification organization. I am under the impression we will need to option a Canadian CSA sticker in the US. Just needing confirmation.
- A1.** See page 8, article 6.11 SACC manual clause B1501C Electrical equipment. All electrical equipment supplied under the Contract must be certified or approved for use in accordance with the Canadian Electrical Code, Part 1, before delivery, by a certification organization accredited by the Standards Council of Canada.
- Q2.** Part 6- Resulting Contract Clauses 6.1 Security Requirements, Page 5: Additional Insurance: We wanted to confirm there are no additional insurance requirements as was previously required during the discussion phase of this project prior to the official solicitation request. StingRay Manufacturing maintains high levels of insurance as required. This is in reference to the SACC Manual Clauses G1005C. Just wanted confirmation I read this correctly.
- A2.** The TA is not aware of any additional insurance requirements.
- Q3.** Item 1.10: 230 Voltage. We noticed the change from 460V to 230V and will reflect this change in our documentation as we can build your StingRay with 230V.
- A3.** The existing washer, which is being replaced, is 240V. The max voltage at the breaker is 600 V.
- Q4.** Annex "B" Item 2: On-Site Installation: Installation: Since the solicitation states no additional funds can be requested, it is very difficult for us to appropriately quote installation. All parts washer manufacturers do not install their equipment as there are regulations in place that local contractors must install utility hook ups. This is why the end user usually installs their equipment rather than the manufacturer. And it is much less to hire local contractors than for StingRay to find local contractors and then be on site during the installation process. Any feedback on this Annex "B" item would be helpful.
- StingRay quoted commissioning and installation supervision, yet the solicitation only requires 1 hour of training. Our standard commissioning is 2 days on site for proper training of your operators and maintenance personnel. Our commissioning quote will be much less if are to only provide 2 days of on-site training without installation supervision and installation. Here is an idea in Item 6.
- A4.** Installation of utility hook ups will be done by WCE on base; there is no requirement for the manufacturer to do so.
- Q5.** Annex "A" Requirement: Item 1.21: Delivery Date: March 31, 2016. The solicitation ends on March 9, which then would only allow for an approximate 1 week build for a complicated large piece of industrial equipment custom configured to meet the specifications in this solicitation. Any feedback would be appreciated.
- A5.** See AMD 001, PART B: REVISIONS Refer to Part 6 article, 6.4.1 Delivery Date. While delivery is requested on or before March 31, 2016, the best delivery date offered is _____.
