Amendment No.002 is being raised to extend the bid closing date by 30 days as per vendors' requests, to answer vendor questions and to correct typos.

Questions and Answers:

Q1: Our major concern is the fact that the incumbent has a considerable advantage presently, and moving forward, when it comes to fulfillment of this contract. As a result of the incumbent 'first mover' position, the incumbent possesses a critical infrastructure asset that no other bidder has. The cost of new construction or retrofit to provide a facility merely equivalent to what is presently in place at 385 Rexdale Boulevard creates a troublesome platform upon which to develop a business model for provision of these services. Therefore, it is our fear that it will be very difficult, if not impossible, for any competitive process to exist in procurement for this contract. Despite the challenges, we are interested in exploring the opportunity further, and giving CBSA and PWGSC a competitive option to the present solution. Due to time required to access information such as Annex A 'Scope of Work' as well as the scope and scale of work required to develop a competitive bid, we see the present time frame as very constricting. This again plays in to the hand of the incumbent. We ask that the committee at very least consider extending the solicitation close deadline by a minimum of thirty (30) calendar days to allow for new vendors to develop the type of high value proposition and solution that the CBSA and PWGSC deserve for this project.

Q2: I have been in contact with my consultants who will be preparing the bid proposal. The general consensus is that with a lot of staff away for the March Break and the amount of work required to prepare a bid, an extension will be needed. We would like to request that the extension be for 30 days.

Q3: We have a hotel located east side of Highway 400, South of 407 near 401 in Toronto. Does our property location qualify within the boundaries that you indicate in the proposal?

A3: Please see the RFP, Part 1, Article 2. bullet (g) which specifies the boundary lines. It appears that your property does not fall within the specified boundary lines.
