AMENDMENT 001

This amendment is raised in order to address bidder questions received as of March 9, 2016:

Question 1: We have noted you have provided 10 working days to respond to the RFP. Assuming you award the contract on Monday March 21, 2016 (thus receiving the files the same day), that only leaves 7 working days (including the delivery day of March 31, 2016) for production due to the Good Friday and Easter Monday holidays. Should you consider changing the RFP deadline date to Tuesday March 15, 2016?

Answer 1: The closing date remains unchanged at this time.

Question 2: At 1.2.1 Hardware, Nomadic C33 Display Frames, do you require 12 full display hardware?

Answer 2: Yes, 12 full displays are required.

Question 3: At 1.2.2 Exhibit Display Murals:

Question 3a): a. 3 Front (concave) panel (88.3125x 89.75) – What are the dimensions of the three centre panels

Answer 3a): 29.4375 x 89.75 is the size of each panel.

Question 3b): b. 2 End panel (15x 89.75) – Is this correct, you want flat end panels? Or do you want curved?

Answer 3b): Printed flat but will curve when installed.

Question 3c): c. 3 Back (convex) panel (97.5x 89.75) – What are these panels for? Is this to brand the back of the display?

Answer 3c): Yes.

Question 3d): Quantity: 16 (4 sets of 4, 3 English, 1 French) – Do you require 16 sets of panels or 16 panels?

Answer 3d): 16 sets are required.
