1. Reference page 1 and amend as follows:

Q1 Can the fax number be confirmed?

A1 Bids transmitted by fax WILL BE ACCEPTED. Bids can be faxed to 204-983-0338.

NOTE: The fax number 204-983-7796 is the general fax for the Winnipeg Acquisitions Office. Questions can be received at this fax, not the bid fax number as the bid fax is located in a locked room and faxes received are not looked at until the solicitation closing date.

Q2 Pump truck is preferred for item 2.a. in the Statement of Work. Is a vacuum truck acceptable?

A2 Vacuum truck is allowed. Reminder that highest standard is expected from industry experts.

Q3 Is the pricing firm for Option year?

A3 As stated in the Basis of Payment, Option year is firm pricing.

Q4 Is there a possibility for disposal of other items?

A4 Unlikely that other items will be added. A Standing Offer already exists through Base Supply. It would be looked at on a case by case basis.

Q5 What is the frequency of hazardous waste removal?

A5 On a weekly basis, but may be called in more frequently.

Q6 How much hose is required to reach small portable tanks?

A6 Trucks can be driven right up to them.

Q7 How often do the small white tanks have to be emptied?

A7 Every few months or when logistically feasible to do so (i.e. contractor on site and time allows or there for an emergency removal and can complete in the same trip).

Q8 Are emergency call-outs written in the Statement of Work?

A8 Emergency removals are handled by contract in place with Construction Engineering section.

If your bid has already been forwarded and you wish to revise the same, this revision should reach the Bid Receiving Unit identified before the closing date. The bid number and closing date are to be clearly identified.
