Unless defined herein the Standard Exclusions will apply; *General Contractors are responsible to include all work that may be excluded from a BidCentral Online Bidding for Subcontractor's (BOBS) Bid as they deem necessary.* This document does not imply a requirement to include work not specified:

### **1. Electrical**

1. This bid shall also include the following work as specified in Division 33 Utilities, Section 33 65 73 Concrete Encased Duct Banks and Vaults:
  1. Electrical conduits in duct banks (Standard Exclusions for civil work, manholes, etc. shall apply).
  2. Directories as specified in 3.5 Conduit Directories.
2. General Contractors should be aware of the following civil related work shown on the Electrical Drawings which is not specified to be part of the Electrical Bid. General Contractors shall include for this work (but not limited to) as they deem necessary:
