Amendment no. 003 is raised to provide a response to questions raised to date and to amend MT1, as follows:

Q13 Mandatory technical criterion MT1, given that yellow belt training has only been officially recognized in the past year, Offerors would not be able to demonstrate the requested five years of yellow belt training experience that resulted in participants receiving certification. Would Canada consider amending MT1 to: "The Offeror must have a minimum of five years of demonstrated experience for the combination of each of the designated belt levels (white, yellow, green and black) and/or master black belt level, as defined in section 1.3 of the Statement of Work to outside clients in both of Canada's official languages within the last seven years as of the RFSO publication date"?

REASON FOR AMENDMENT:

1.0 Delete mandatory technical criterion MT1 in its entirety and replace with:
