QUESTION FOR CLARIFICATION

Q1 "Under Section 3.2.3 – Past Experience, Item 2 a), it states that projects must include (1) project for a designated structure/lighthouse/fixed bridge less than 10m". Can you please confirm that (1) project must be EITHER a designated structure, OR a lighthouse OR a fixed bridge? Or are you looking for (1) project for EACH of these categories?

A1 One project must be either a designated structure, OR a lighthouse OR a fixed bridge.

Q2 "Reference is made to sections 3.2.4 Senior Personnel and 3.2.5 Project Personnel. Our intent is to identify some staff under the two sections to reflect both the seniority evaluated in 3.2.4 and the qualification of the staff that will perform the work per 3.2.5. Would this duplication adversely affect the rating of the proponent on either of these sections?"

A2 Yes, any duplication will adversely affect the rating of the proponent on either of these sections.
