AMENDMENT 002

This amendment (**002**) is raised to **a)** extend the solicitation closing date and **b)** publish clarification sought by Industry.

a) Extend the bid closing date to May 12th, 2016

The solicitation closing date and time, as stated on page one of this solicitation, is hereby amended to **2:00PM Eastern daylight saving time on May 12th, 2016.**

b) Question and Clarification:

Question 1: In the fourth paragraph of clause 5.1.2 of the RFSO, reference is made to **Annex D** Federal Contractors Program for Employment Equity - Certification. Please confirm that this reference should, in fact, read **Annex C** - Federal Contractors Program for Employment Equity - Certification.

Clarification 1: Canada confirms clause 5.1.2 Federal Contractors Program for Employment Equity – Certification should reference Annex C located in the fourth paragraph.

- i. Delete **5.1.2 Federal Contractors Program for Employment Equity - Standing Offer Certification** in its entirety;
- ii. Replace **5.1.2 Federal Contractors Program for Employment Equity - Standing Offer Certification** with the following:

5.1.2 Federal Contractors Program for Employment Equity - Standing Offer Certification

By submitting an offer, the Offeror certifies that the Offeror, and any of the Offeror's members if the Offeror is a Joint Venture, is not named on the Federal Contractors Program (FCP) for employment equity "FCP Limited Eligibility to Bid" list (http://www.labour.gc.ca/eng/standards_equity/eq/emp/fcp/list/inelig.shtml) available from Employment and Social Development Canada-Labour's website.

Canada will have the right to declare an offer non-responsive, or to set-aside a Standing Offer, if the Offeror, or any member of the Offeror if the Offeror is a Joint Venture, appears on the "FCP Limited Eligibility to Bid" list at the time of issuing of a Standing Offer or during the period of the Standing Offer.

Canada will also have the right to terminate the Call-up for default if a Contractor, or any member of the Contractor if the Contractor is a Joint Venture, appears on the "FCP Limited Eligibility to Bid" list during the period of the Contract.

The Offeror must provide the Standing Offer Authority with a completed Annex C - Federal Contractors Program for Employment Equity - Certification, before the issuance of a Standing Offer. If the Offeror is a Joint Venture, the Offeror must provide the Standing Offer Authority with a completed annex Federal Contractors Program for Employment Equity - Certification, for each member of the Joint Venture.

ALL OTHER TERMS AND CONDITIONS REMAIN THE SAME
