This solicitation is hereby amended to provide the following questions and answers:

Question 1.

In Annex A you state that the exterior saturated colour "Forest Green 68" is applied. According to the Sansin website, "Forest Green" is 69 and Hunter Green is 68. Please confirm colour and code.

Answer 1.

The correct colour should be "Forest Green 69"

Question 2.

Also, regarding the wood shingle finish can I assume that we are able to either spray or paint the finishes on. And if so are both sides necessary to be stained and finished?

Answer 2.

The shingles are to be pre-treated: one coat of the SDF and one coat of the ENS finish prior to installation, with a final coat of ENS once the shingles are installed (ENS material to be included with shingles for final coat on site be shingles installer). The shingles should be coated on both sides and the process for coating the shingles should be as per the manufacturer's instructions.
