# ACAN – Accreditation of the National Laboratory for Environmental Testing in Burlington, Ontario and Saskatoon, Saskatchewan

## 1. Advance Contract Award Notice (ACAN)

An ACAN is a public notice indicating to the supplier community that a department or agency intends to award a contract for goods, services or construction to a pre-identified supplier, thereby allowing other suppliers to signal their interest in bidding, by submitting a statement of capabilities. If no supplier submits a statement of capabilities that meets the requirements set out in the ACAN, on or before the closing date stated in the ACAN, the contracting officer may then proceed with the award to the pre-identified supplier.

## 2. Definition of the requirement

The Department of the Environment (DOE) has a requirement for its operational laboratories to meet ISO 17025 quality standards. The Canadian Association for Laboratory Accreditation (CALA) is the only recognized Canadian institution which provides complete accreditation services, training and provision of proficiency testing samples and other support services. The work will involve the following:

- a) Annual Canadian Analytical Laboratory Association membership for the National Laboratory for Environmental Testing in Burlington, Ontario and Saskatoon, Saskatchewan
- b) Annual accreditation (is this provision of on-site assessment for NLET Burlington and NLET Saskatoon based on ISO/IEC 17025 standards?) and maintenance fee
- c) Participation in Performance Testing rounds twice per year. This includes the provision

## 3. Criteria for assessment of the Statement of Capabilities (Minimum Essential Requirements)

Any interested supplier must demonstrate by way of a statement of capabilities that its products and services meet the following requirements:

- Must be able to deliver laboratory accreditation in environmental testing based on the NLET Burlington and NLET Saskatoon's satisfactory participation in a site assessment program plus satisfactory participation in proficiency testing.
- 2) Must be able to provide a site assessment program which audits and evaluates NLET Burlington and NLET Saskatoon's laboratory performance at regular intervals. The Laboratories must be assessed to the ISO/IEC standard in accordance with the ISO/IEC 17011 standard. The interested supplier must conduct on-site assessments on a regular basis using highly trained (formal training on ISO/IEC 17025) assessors
- *3)* Must be able to provide a proficiency test program which consists of:
  - a. two studies per year for the two disciplines of inorganic and inorganic chemistry in both solid and water matrices
  - a confidential report for each study which contains the performance evaluation for each analyte that NLET Burlington and NLET Saskatoon reports results for in the study
- 4) Must be fully conformant to the new international PT standard ISO/IEC 17043: 2010

### 4. Applicability of the trade agreement(s) to the procurement

This procurement is subject to the following trade agreement: North American Free Trade Agreement (NAFTA)

## 5. Justification for the Pre-Identified Supplier

CALA is the only recognized Canadian institution which provides complete accreditation services, training and provision of proficiency testing samples and other support services. The DOE has a laboratory data quality policy that compels all operational analytical laboratories in the DOE to meet ISO 17025 quality standards. Meeting this standard ensures that the DOE operational laboratories achieve and demonstrate the highest levels of scientific and management excellence through the combined principles of competence, consistency, credibility and communication. It is one of the steps that enable data from the DOE scientific programs to be accepted as authoritative around the world.

CALA also provides multiple guidance documentation to its membership which assist its laboratories with meeting ISO17025 requirements. In addition, CALA supports its membership through providing discounted training in relative topics to laboratory accreditation and management.

## 6. Government Contracts Regulations Exception(s)

The following exception(s) to the *Government Contracts Regulations* is *(are)* invoked for this procurement under subsection 6(d) - "only one person is capable of performing the work".

## 7. Exclusions and/or Limited Tendering Reasons

The following exclusion(s) and/or limited tendering reasons are invoked under the North American Free Trade Agreement (NAFTA) – Article(s) 1016

An entity may use limited tendering procedures in the following circumstances and subject to the following conditions, as applicable:

where, for works of art, or for reasons connected with the protection of patents, copyrights or other exclusive rights, or proprietary information or where there is an absence of competition for technical reasons, the goods or services can be supplied only by a particular supplier and no reasonable alternative or substitute exists; (CAP Code 71)

## 8. Ownership of Intellectual Property

Ownership of any Foreground Intellectual Property arising out of the proposed contract will vest in the Contractor.

## 9. Period of the proposed contract or delivery date

The proposed contract is for a period of one year, from April 1, 2016 to March 31, 2017. The contract includes an option to extend the contract period, for two one-year periods from April 1, 2017 to March 31, 2018 and from April 1, 2018 to March 31, 2019.

## **10. Estimated Value of the Contract**

The estimated value of the contract, including options, is \$90,000.00, HST extra.

The closing date and time for accepting statements of capabilities is April 5, 2016 at 2:00 p.m., DST.
