Question 1.

Can DND supply the previous 1 and 2 year history of the lift service and roll-off weight (20-40 yd.) container service that are listed under "as and when requested" for the waste, cardboard and wood services?

Answer 1.

No. DND cannot provide this information at this time, previous history is not available.

Question 2.

Is it acceptable for the incumbent to use CFB Borden as a reference?

Answer 2.

Yes, it is acceptable.

Question 3.

Section 4.1.1.1, under Definition: Similar Size and Scope, it states the number of cancart for recycling are within 60% of the number involved in this requirement. (This requirement involves 500 cancart.) Is it acceptable to reference equivalent yardage, i.e. 4 cancart is equivalent to a 2-yard bin.

Answer 3.

Each cancart is equivalent to a 95 gallon wheeled tote.

Question 4.

We'd like to know if it's possible to get Annex A-1, A-2, and A-3, in an Excel format? This would be very helpful for our analysis.

Answer 4.
