### Amendment 003

The purpose of this amendment is to answer questions from potential bidders.

#### QUESTION 1:

Would it be possible to have the pantone reference color for the fabrics?

**ANSWER:** We do not have a Pantone colour. A material colour swatch will be provided at the pre-award stage.

#### QUESTION 2:

The specification G.S.1045-301 refers to the item #5260 Trousers, inclement as well as items #5266 Yellow, Stripe Inclement, #5271 Blue, Stripe Inclement and #5276 Fluorescent, Stripe Inclement. However, does the item #5260 Trousers, inclement come with all the 3 available stripes?

**ANSWER:** The trouser comes without a stripe. The stripes are ordered separately.

#### QUESTION 3:

Specification G.S.1045-301: Should the hide away flap be cut from material III (which is yellow) as stated or should it be from material II (Fluorescent yellow-green)?

**ANSWER:** The flap shall be fluorescent yellow-green as per the specification.

#### QUESTION 4:

In 6.4.1, do we have to determine the number of days for each garment or it will be completed at the award of the contract?

#### ANSWER:

Both, we ask bidders to complete this section and it will be completed at the contract award stage based on the winning bidders' proposal.
