- A1. No, this will not be removed.
- Q.2 Does the Military Police Complaints Commission follow the same policy as PWGSC which states" To ensure a consistent approach to the public disclosure of information, PWGSC will release on a routine basis the unit prices and labour rates contained in standing offers for goods and services. Offerors must be informed of PWGSC's intention to disclose unit prices and labour rates contained in successful offers in the event of a resulting standing offer. General conditions 2005(2015-09-03 General conditions standing offer goods and services of the Standard Acquisition Clauses and Conditions (SACC) Manual include a provision to this effect.
- A.2 The MPCC does not routinely disclose this information.
  However, a standing offer (SO) is an offer from a supplier to
  Canada that allows Canadian departments, agencies and Crown
  Corporations to purchase goods and/or services at
  predetermined pricing. A standing offer itself is not a contract,
  therefore the rates are considered public.
