#### **Amendment 02**

This amendment is being raised to change the solicitation closing date, distribute bidder questions and answers submitted by email and to make changes to the specifications.

## **CLOSING DATE:**

The closing date for tender 5P420-16-5013A, titled *TCH Clearing and Brushing - Yoho National Park*, is extended from March 30, 2016 until April 5, 2016 at 2:00PM Mountain Daylight Time (MDT).

## A. BIDDER QUESTIONS:

- Q1 The timeframe represents an impossible challenge with regard to the clearing milestone of April 29. If the project is awarded on March 30 and then the successful proponent has to submit a list of critical documents that then require a 20 day review and acceptance by the contract representative. This would leave only a few days to cut and haul approximately 51 hectares. While not impossible, it would require full closure of the highway. My suggestion is relaxing the milestone or shortening the review period or both.
- A1 Refer to Amendment 1 which extended the clearing and brushing milestone date to May 16. The Departmental Representative will review document submissions within 2 business days of receipt in order to expedite post award construction lag time. Note that the underlying primary purpose of the clearing and brushing milestone date is to limit tree felling activity during the breeding bird period.
- Q2 The distinction between "clearing and brushing" and "cleaning, chipping and removal" seems vague. What are the clear delineations between these two phases? The definition page leaves the reader slightly unclear.
- A2 Clearing and Brushing means cutting trees, brush and vegetative growth to within 75mm of the ground.
- Q3 There is existing felled timber within the project scope but it is not clear in the definitions if these are to be removed inside the scope. Please clarify if this is to be included.
- A3 Existing felled timber that falls within the identified project limits is required to be removed under the project scope.
- Q4 The requirement to cut and stack firewood; please clarify what is meant by "stacking" Also, please note that there could be in excess of 800 cords.
- A4 Refer to Amendment 1 which removed the requirement to "stack" merchantable timber and now only requires "stockpiling".
