## **QUESTION AND ANSWERS**

### **Question 3**

Under Annex E the section Instructions To Bidder

Section 1.04 Qualification

Subsection 0.2 – this states that the contractor must own and operate a hazardous waste transfer facility in the Maritimes that is capable of receiving and storing all types of hazardous waste indicated in the attached Annex A. On Annex A items 18, 19, 29, 30 & 43 are PCB materials – we are not permitted to transport or store PCBs at our facility. We can however arrange for transport by a licensed hauler to a permitted facility. Also, item #37 water with bisulfates 40,000L – that is above our permitted level for that class of waste in addition to not having the storage capacity. We can however arrange for transport by a licensed hauler to a permitted facility. – Please advise if it is acceptable to bid this way.

### **Answer 3**

The Contractor must own and operate a hazardous waste facility which will be inspected by the Manger as per Section 1.04 Qualifications line .2.

### **Question 4**

Section 1.13 Equipment

Subsection 0.2 – this states that the contractor must have the trucks and transportation services required to transport the volumes and types of hazardous waste stipulated in this specification. Again we cannot transport PCBs as we are not permitted for that; and we don't have a unit to haul the 40,000L of bisulfate water. We would need to hire 3rd party for both these.

Subsection 0.5 – this states that no sub-contractor will be used unless authorized by the Engineer. Please advise if we can obtain authorization for this before bidding for the two types of waste as we would need to subcontract the transport?
