Amendment No.003 is being raised to allow for viewing of the Annex A Statement of Work by vendor representatives holding valid Reliability Status granted by CISD where the vendor holds valid security clearance at or exceeding DOS but does not have Document Safeguarding at the level of Protected B, to correct typographic error, to amend the scoring grid to ensure the scoring grid descriptions matches the technical point-rated criteria that it applies to, and to answer vendor questions.

- "1) Annex A, Statement of Work including 3 appendices is an 85-page Protected B document that:
- a) Will be provided to those holding the following security clearances upon Bidder's request:
 - i) Bidders holding a valid Designated Organization Screening (DOS) with Document Safeguarding at the level of Protected B issued by the CISD; and
 - ii) the named Bidder's representative(s) holding valid Reliability Status granted by the CISD.
- OR
- b) Will be made available for up to 8 hours of document viewing per vendor upon Bidder's request:
 - i) Bidders holding a valid Designated Organization Screening (DOS) without Document Safeguarding at the level of Protected B issued by the CISD; and
 - ii) the named Bidder's representative(s) holding valid Reliability Status granted by the CISD.
- 2) PWGSC must be able to validate the Bidder and the named Bidder's representative(s)' security clearances with the CISD before making Annex A, Statement of Work available to the Bidder.
- 3) To request for a copy of the Annex A, the Bidder must provide to the Contracting Authority:
- a) Bidder's legal company name and company address that holds the DOS with Document Safeguarding at the level of Protected B issued by CISD;
 - b) The legal name and date of birth of the named Bidder's representative who will receive the Annex A, Statement of Work;
 - c) Bidder's preferred document deliver method:
 - i) via in-person pick-up by the named Bidder's representative at the PWGSC office at 33 City Centre Drive – Suite 480C, Mississauga, Ontario; or
 - ii) via Canada Post courier delivery to the Bidder's company address holding the required valid CISD security clearance with the package addressed to the named Bidder's representative.

- 3) To request for a document viewing of the Annex A, the Bidder must provide to the Contracting Authority:
- a) Bidder's legal company name and company address that holds the DOS without Document Safeguarding at the level of Protected B issued by CISD;
 - d) The legal name and date of birth of the named Bidder's representative(s) who will view the Annex A, Statement of Work;
 - c) Bidder's preferred document viewing date and time between Monday to Friday EST 8:00a.m. to 4:00p.m., excluding holidays, taking place at the PWGSC office at 33 City Centre Drive –

Suite 480C, Mississauga, Ontario or an alternative PWGSC office in Canada. While Bidder's preference will be taken into consideration, PWGSC reserves the right to determine the document viewing date, time and place for each Bidder based on space and resource availability.

- 4) Security validation could take up to 2 business days. Once PWGSC confirms that the Bidder and the named Bidder's representative all hold the security clearances stated in 1 a) above, PWGSC will provide a copy of the Annex A, Statement of Work through the Bidder's preferred document delivery method.

- 4) Security validation could take up to 2 business days. Once PWGSC confirms that the Bidder and the named Bidder's representative(s) hold the security clearances stated in 1 b) above, PWGSC will arrange for the Annex A Statement of Work to be available for viewing by the named Bidder's representative(s).
- 5) The Statement of Work including appendices will be included as part of the resulting contract at the time of contract award. The instructions from 1) to 6) listed on this page will be replaced with "See attached".

Question and Answers

Q: We believe that our office space and personnel meet the requirements, and therefore expect to complete the Document Safeguarding Protected B registration process quickly, is there any guidance that you or your team can provide?

Our teaming partner was also suggested to register for the clearance, could you please advise if we were to centralize the project team in to our approved offices, would that permit us from avoiding the additional delay/risk of registering our "supplier/teaming partner"? Alternatively, we would look to respond as a sole entity.

We are one of the preferred operators of facilities around the world, and are currently involved in diverse transport, housing, defence, and other programs for the Government of Canada. Our team have recently completed projects which meet the scope of these works, including the largest immigration detention centre in North America, which we understand to be the second largest globally. We have a prepositioned detention centre which is rapidly deployable, and we believe our solution and experience represents a best value solution to your solicitation.

As a result of our delays due to registration of Protected B, and in consideration to the above and our ability to deliver value and compliance, we request an extension of 21 calendar days to complete the clearance processes, and a high quality offer for the Government of Canada. We fully appreciate that an extension has already been granted.
