This amendment 005 is raised to amend the attached RFP and to answer to a question.

### **Amendment**

1. In Annex 2, Section 1 – Statement of Work, **add** the following under 4.1. General:

The Project Manager must not submit, either directly or indirectly, a bid for any other contract(s) related to the Project.

### **Question and answer**

#### **Question 1**

The RFP requires the Project Manager to contract a Design Consultant for Architectural and Engineering related services. This means that the liability and risk associated with the Architectural and Engineering related services transfer to the Project Manager. As the Project Manager *is required to provide these services under contract, is the Project Manager free to self-perform* any or all of the Architectural and Engineering services *without conflict*?

#### **Answer 1**

The Project Manager must perform the work as define in Annex 2, Section 1 – Statement of Work (SOW). As mentioned in the SOW, the Design Consultant contract must be awarded through a competitive process lead by the Project Manager and as such, the Project Manager would be in a conflict of interest if it was to bid on its own request for proposal. Also, see amendment 1 above.

All other terms and conditions remain the same.
