Yes. Each project showcased must be a minimum of one (1) year in duration and the resource must claim the total amount of time supporting that project. The term 'project' is defined in the RFP and will be evaluated per this definition.

2	In Attachment 2.2, Project Management Support Services (PMSS) at page 156 of 169, PMSS Corporate Criteria MRC1: The bidder is required to demonstrate experience in 5 TBIPS categories using only 5 contracts. This can be challenging given the variety of categories requested to demonstrate. As an example, P.13 resources are usually procured under short distinct contracts and multiple contracts would be needed to fulfill the requirement. Would the Crown please consider accepting demonstration of all the categories with 7 contracts (as opposed to 5) in order to allow for multiple short contracts to be presented specifically under the P.13 category?	Different contracts can be used to demonstrate the experience of different resources. Canada will entertain additional contracts to demonstrate the experience, however, the experience must be against a project as defined in this RFP. P.13 is being removed from MRC1 – see Q2.
2	In Attachment 2.2, Project Management Support Services (PMSS) at page 156 of 169, PMSS Corporate Criteria MRC1: The bidder is required to demonstrate 120 days for P.13, 13 Independent IT Project Review Team Leader. This is very specific and significantly reduces the number of days that can be presented and it also does not reflect the actual bidder's experience in the area of IT Project Review. It is our experience that the IT Project Review Team Leader and the IT Project Reviewer perform very similar work and usually work together very closely as a team to establish the Project Review Plan, developing the .review report and performing quality assurance for the work. It would not be possible to complete the Independent Review without the team members all being extensively involved and participating at all levels. The Team Leader and Project Reviewer stand in for one another where the Team Lead on Project 1 may be a Team Member on Project 2 and vice versa, given that they need to be very experienced and essentially have the same skills sets. Would the Crown please change this item to read: P.13 Independent IT Project Review Team Leader OR P.14 Independent IT Project Reviewer?	See Q2
