Amendment 003 is raised to answer bidder's questions, revise 4.1.1 Mandatory Technical Criteria and change the closing date on the front page as follows:

The Front page of Solicitation Amendment 003:

Delete: Eastern Standard Time

Inserted: Eastern Daylight Saving time.

Question 1.

Please clarify the equipment required and provide the total number of bins, totes and can carts and their respective sizes.

Answer 1.

The total number, location, and type of unit(s) are identified in Annexes A-1, A-2, & A-3 for the firm requirement and "as-and-when-requested" task authorization work. The estimated quantities for the "as-and-when-requested" work will fluctuate the amount of units, increasing or decreasing the units over the period of the contract.

Question 2:

Concerning mandatory technical criteria M-1, the contractor must submit 2 references for a commercial/industrial building in which the reference is within 60% of the number of bulk waste bins (156 bulk waste bins) and 60% of the number of recycling can carts (300 can carts) of Base Borden.

Would Base Borden consider allowing the references to be municipal if it meets the required percentage of bin volume (60%)?

Answer 2:
