This amendment is raised to make the following changes;

1- In Annexe A at 5.3.4 Collaborative - Table #4 to be deleted and replaced with the following:

5.3.4 Collaborative - Table #4

5.3.4.1 Description:

5.3.4.1.1 Cone shape or trumpet shape end table.

5.3.4.1.2 Top of table to be round.

5.3.4.1.3 For the cone shape table only, underside of table top to be cone shape with an insert table top and top to look like it is floating in cone frame.

5.3.4.1.4 Cone shape base is to be a tailored cone shape leg. Trumpet shape base is to be shaped like a trumpet leg.

5.3.4.2 Finishes:

5.3.4.2.1 Cone shape table top to be finished with corian (hard surface) or gloss high pressure laminate. Trumpet table top to be high pressure laminate with vinyl edging to match.

5.3.4.2.2 The cone shape underside top to be painted metal.

5.3.4.2.3 The tailored based leg cone shape to be wood veneer. The trumpet base leg to be metal finish.

5.3.4.3 Dimensions:

5.3.4.3.1 Top to be 21'' to 24'' diameter.

5.3.4.3.2 Table height to be from 20'' to 24''H.

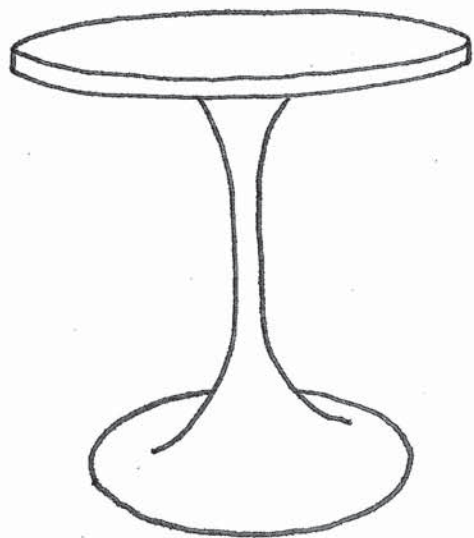

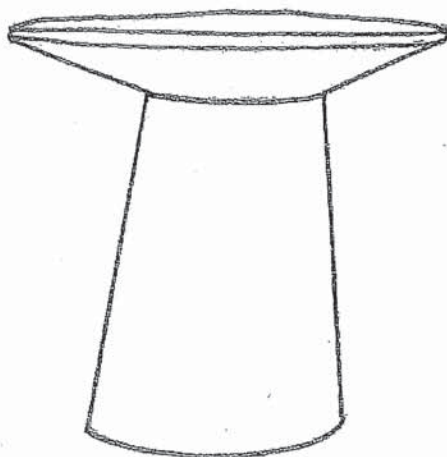
