



Appendix A - Equipment Table

Item	Equipment Description	Quantity
1.	Storage Space: Minimum dimension 15x20 ft (5x6 m). Must be secured, with dedicated access to the entire CF detachment. Storage space must be large enough to accommodate forklift access. Storage must be available on the secured side of the airfield, where DND personnel is permitted to operate. Storage space must be completely enclosed to provide protection from the elements (rain, wind, etc).	1
2.	Mobile stairs for passengers to board or exit the aircraft capable of servicing CC-150 (Airbus A 310) wide body aircraft, minimum of 245 inch (6.22 m) height, complete with: a) rubber bumper at the platform front to protect the aircraft; b) slide rails shall be equipped with serviceable rubber bumpers for aircraft protection; and c) this item is required with an operator.	1
3.	Utility Dolly (hand truck), to be used by CF for loading and unloading, minimum carrying capacity of 200 lbs (90 kg).	2
4.	Luggage Cart or similar, to be used by CF for moving parts and equipment to and from the aircraft.	1
5.	Tow tractor (mule) for CP-140 Aurora – This particular model is compatible with the CP-140 Aurora and is desirable, as per diagram 1 Annex B to the SOR;	1
6.	The Bidder may be required to provide hangar space for emergency repairs, suitable for a CP-140 Aurora, if available. The CP-140 Aurora dimensions are: a) length: 117 ft (35.66 m) b) wingspan: 100 ft (30.48 m) c) height: 37 ft (11.28 m) The space is to be made available on an as and when requested basis.	1
7.	Forklift minimum 10 ton payload (which only the forks lift), as per diagram 2 AppendixC to the SOR, to be operated by CF personnel. If 10 ton is not available, 5 ton or 2 ton is acceptable. Bidder must be responsible for forklift fueling and re-fueling. Ready to work 12 hours after phone call;	Min 1, Max 2
8.	(If available) Loader Truck, as per diagram 3 Annex B to the SOR (K-Loader; not a split loader) Contractor must provide operator for K-Loader. Contractor must be responsible for K-Loader fueling and re-fueling	1

9.	Cherry-Picker (An elevated work platform, man lift, basket crane) allowing the CAF crew to make repairs to the aircraft, if needed.	1
10.	Toilet services for the CP-140 Aurora, and the Support Aircraft: C-17 Globemaster, CC-130 Hercules, or CC-150 Polaris (Airbus). Note: The Aurora does not use a toilet service truck. Services for the cleaning of urinals and toilet tanks would be sufficient for the CP 140 Aurora.	1
11.	Water service truck capable of servicing the Support Aircraft: C-17, CC-130 Hercules, or CC-150 Polaris (Airbus). This item is required with an operator.	1
12.	Garbage disposal services, if available: Includes liquid, semi liquid and solid garbage generated by aircraft crew. Garbage disposable services must be conducted in accordance with local regulations on waste disposal.	
13.	Hazardous waste disposal services may be required, and will be called up on an as and when required basis.	
14.	Diesel Fuel for CAF Ground Handling Equipment	Estimated to be approximately 200 to 1,000 liters depending on the aircraft repairs required
