Answer 8

The dates for the initial contract and option periods were not an omission. The actual dates for each period will be included at contract award. The estimated periods for the initial contract period and the option periods are provided within the Notice of Proposed Procurement (NPP) and the Request for Proposal (RFP). Please refer to the NPP, Number and proposed period of contract(s): "It is intended to result in the award of 1 contract for 1 year plus 4 one-year irrevocable options allowing Canada to extend the term of the contract." In addition, please refer to the Request for Proposal, Part 1 – General Information, article 1.2 Summary, (b) "It is intended to result in the award of 1 contract for one year plus 4 one-year irrevocable options allowing Canada to extend the term of the contract" and Part 7 – Resulting Contract Clauses, article 7.6, Contract Period:

- (a) **"Contract Period:** The **"Contract Period"** is the entire period of time during which the Contractor is obliged to perform the Work, which includes:
- (i) The **"Initial Contract Period"**, which begins on the date the Contract is awarded and ends 1 year later; and
 - (ii) The period during which the Contract is extended, if Canada chooses to exercise any options set out in the Contract.
- (b) **Option to Extend the Contract:**
- (i) The Contractor grants to Canada the irrevocable option to extend the term of the Contract by up to 4 additional 1-year periods under the same terms and conditions. The Contractor agrees that, during the extended period of the Contract, it will be paid in accordance with the applicable provisions set out in the Basis of Payment.
 - (ii) Canada may exercise this option at any time by sending a written notice to the Contractor before the expiry date of the Contract. The option may only be exercised by the Contracting Authority, and will be evidenced, for administrative purposes only, through a contract amendment."

ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED
