## PART 1 - GENERAL INFORMATION

### 1.1 Requirement

The requirement is detailed under Article 6.2 of the resulting contract clauses.

### 1.2 Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

### 1.3 Trade Agreements

The requirement is subject to the provisions of the North American Free Trade Agreement (NAFTA), and the Agreement on Internal Trade (AIT).

## PART 2 - BIDDER INSTRUCTIONS

### 2.1 Standard Instructions, Clauses and Conditions

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the [Standard Acquisition Clauses and Conditions Manual](https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual) (<https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual>) issued by Public Works and Government Services Canada.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

### 2.2 Submission of Bids

Bids must be submitted only to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by the date, time and place indicated on page 1 of the bid solicitation.

### 2.3 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than 15 calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

## 2.4 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Alberta.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

## PART 3 - BID PREPARATION INSTRUCTIONS

### 3.1 Bid Preparation Instructions

Canada requests that Bidders provide their bid in separately bound sections as follows:

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Canada requests that Bidders follow the format instructions described below in the preparation of their bid:

- (a) use 8.5 x 11 inch (216 mm x 279 mm) paper;
- (b) use a numbering system that corresponds to the bid solicitation.

In their technical bid, Bidders should explain and demonstrate how they propose to meet the requirements and how they will carry out the Work.

#### Section II: Financial Bid

Bidders must submit their financial bid in accordance with the Basis of Payment. The total amount of Applicable Taxes must be shown separately.

## ANNEX "A"

### REQUIREMENT

#### SCOPE

- 1.1** Purpose. The intent of this document is to define the technical specifications for equipment to augment telemetry data acquisition, recording, distribution and playback equipment.
- 1.2** Background. The Aerospace Engineering Test Establishment (AETE) employs telemetry auto-tracking systems, receivers, diversity combining and bit synchronizing equipment. There is a need to acquire a system for the acquisition, recording, distribution and playback of multiple streams of PCM data, serial data and video imagery, in the Flight Test Control Room (FTCR).

#### 2.0 APPLICABLE DOCUMENTS

- 2.1** Applicability. The following documents form part of this Technical Specification to the extent specified herein.

#### 2.2 STANDARDS

- 2.2.1** IRIG 106-11 (Part 1), Chapter 4, June 2011
- 2.2.2** IRIG 106-09, Telemetry Standard, Chapter 10, April 2009

#### 3.0 SYSTEM REQUIREMENTS

##### 3.1.1 General Characteristics

- 3.1.1** Description. The Chapter 10 Ethernet Data Distribution and Recording System, here-after called the system, must be comprised of integrated components capable of acquiring, recording, playing back and distributing PCM data, serial data. The system must be able to record video imagery. The system must be a proven product from an establish production line.
- 3.1.2** User Interface. The system must have an integral user interface to allow the user to enter and observe all operating parameters.
- 3.1.1** Configuration. The system must be capable of storing all operating parameters and allow the user to configure the system for operation from stored parameters.
- 3.1.2** Time Sync. The system must be able to accept and use IRIG-B time to time stamp recorded data.
- 3.1.3** Remote Operation. The system must be capable of remote operation via an Ethernet link.

### **3.2 Data Types**

- 3.2.1 Description.** The system must provide inputs for the following signal types.
- 3.2.2 PCM.** The system must provide inputs for at least eight streams of PCM data as defined in the paragraph 2.2.1. The system must provide the status of the frame lock for each PCM channel in software and hardware outputs.
- 3.2.3 Serial.** The system must provide inputs for at least four serial data streams at data rates of less than or equal to 300 Baud, to equal to or greater than 19.2 kBaud.
- 3.2.4 Video.** The system must provide inputs for at least four NTSC video streams with at least one audio channel per video stream.
- 3.2.5 IRIG-B.** The system must use IRIG-B time code, AC or DC vendor choice.

### **3.3 Recording**

- 3.3.1 Description.** The system must record all input signals in the IRIG 106 Chapter 10 format, as defined in paragraph 2.2.2.
