This amendment is being raised to distribute questions and answers from the optional site visit held on April 11, 2016 and change the solicitation closing date.

CLOSING DATE:

The closing date for tender 5P420-16-5024A, titled *Visitor Centre Repairs & Maintenance - Banff National Park*, is extended from April 19, 2016 until April 21, 2016 at 2:00PM Mountain Daylight Time (MDT).

A. SITE VISIT QUESTIONS:

Q1 Question regarding A4.0 note about "Vinyl insert".

A1 No, new windows are not included in scope, this note is only to clarify that some windows have vinyl inserts and some do not.

Q2 Scaffolding

A2 The use of scaffolding in the back alley will require Contractor to obtain a Street Us Permit from the Town of Banff. Scaffolding and lay down area set up will have to be coordinated with the Operational team at the Visitor Centre to ensure minimum disruption for staff and visitor access and parking,

Q3 What is the roofing material on the eyebrow dormers?

A3 Copper

Q4 Front door refinishing scope.

A4 Refinish the entire doors

Q5 Refinishing of timbers at stucco

A5 Paint lines as per existing method - fronts brown and side match stucco

Q6 Sill and timber material

A6 The 2014 condition assessment does not clarify the type of wood

Q7 Eaves troughs and down spouts

A7 Include the repainting of both

Q8 Window painting

A8 The exterior surface only

Q9 Sign structure

A9 Exclude the wood portion of the sign. Top course between wood and stone to be re pointed.

All other terms and conditions remain unchanged.
