Different contracts can be used to demonstrate the experience of different resources. Canada will entertain additional contracts to demonstrate the experience, however, the experience must be against a project as defined in this RFP. P.13 is being removed from MRC1 – see Q2.

The Team Leader and Project Reviewer stand in for one another where the Team Lead on Project 1 may be a Team Member on Project 2 and vice versa, given that they need to be very experienced and essentially have the same skills sets.
