This amendment No. 001 is raised to address questions and changes regarding Solicitation W0118-16TX01/A as follows:

PART A: QUESTIONS AND ANSWERS

I would like to request the following clarifications:

Page 15 of 29 – 3.0 Vehicle and Trailer Requirements

Item 1: (excerpt) Vehicles and trailers offered must be no more than three (3) years old, in good repair, in clean condition and with a full fuel tank(s) as applicable.

Q1: Will the customer accept trailers that are greater than three (3) years old and are in compliance with Canadian Motor Vehicle Safety Standards, in compliance with a provincial government safety certificate, in good repair, in clean condition and with a full fuel tank(s) as applicable?

A1: We will accept up to 5 years old, and are in compliance with Canadian Motor Vehicles Safety Standards, in compliance with a Provincial government safety certificate, in good repair, in clean condition and with a full fuel tank(s) as applicable

Item 6: The offeror is required to maintain insurance coverage on each vehicle in compliance with the minimum required by the province having jurisdiction.

Q2: As the trailer(s) cannot be operated without a primary towing vehicle, insurance coverage for liability is automatically extended from the primary towing vehicle to the trailer. Responsibility for insurance coverage for physical loss to the trailer remains with the lessee.

A2: No Change

Page 26 of 29 – Annex C – Insurance Requirements (all items)

Q3: With respect to the operation of a non-powered trailer only, once the trailer is in the care, custody and control of the lessee, the lessee assumes responsibility for the operation of the trailer.

The primary towing vehicle, as mandated by legislation, must have appropriate vehicle insurance with coverage for third party liability.

This liability coverage is automatically extended from the primary towing vehicle to the trailer. The lessee is responsible for all insurance coverage appropriate for the operation of a motor vehicle, including tractor and trailers.

Further, we currently enjoy standing offer EW479-160236/001/EDM, for the rental of various semi-trailers requested by the Government of Canada and the Department of National Defence. Will the customer accept similar insurance coverage as submitted to and accepted by Public Works Government Services Canada for the issuance of this standing offer EW479-160236 to our company?

B. RESULTING CONTRACT CLAUSES

6.6 Insurance Requirements

The Contractor must comply with the insurance requirements specified in **Annex C**. The Contractor must maintain the required insurance coverage for the duration of the Contract. Compliance with the insurance requirements does not release the Contractor from or reduce its liability under the Contract.

The Contractor is responsible for deciding if additional insurance coverage is necessary to fulfill its obligation under the Contract and to ensure compliance with any applicable law. Any additional insurance coverage is at the Contractor's expense, and for its own benefit and protection.

DELETE: Vehicles and Trailers offered must be no more than three (3) years old, in good repair, in clean condition and with a full fuel tank(s) as applicable. Canada may refuse to accept the provision of any vehicle or trailer that is more than 3 years old.

INSERT: Vehicles and Trailers offered must be no more than five (5) years old, in good repair, in clean condition and with a full fuel tank(s) as applicable. Canada may refuse to accept the provision of any vehicle or trailer that is more than 5 years old.
