**BASIS OF PAYMENT**

Firm unit prices are in Canadian dollars, the Goods and Services Tax (GST) excluded, delivered Incoterms 2000 FOB destination address specified, and customs duties and excise taxes included. GST is not to be included in the unit prices. GST will be added as a separate item to any invoice issued.

Firm unit price shall be inclusive of all direct and indirect expenses incurred in performing the Requirement. The rates below shall include all costs for vehicle licensing, permits, insurance, full maintenance due to normal wear and tear, replacement of tires and tire repairs, all warranty servicing, driver, and fuel. Quotes price shall include stated insurance requirement and unlimited mileages. Only buses used shall be charged for. DND shall not be liable for any costs should cancellation by Contractor occur.

For all trips over 100km, an additional rate will be charged on every kilometer driven over 100km.
