This Solicitation Amendment No. 7 is raised to include the following Addendum No. 7.

The following addendum to the Request for Proposal Document is effective immediately. This addendum shall form part of the Contract Documents.

All other terms and conditions remain the same.

Addendum No. 7

QUESTIONS AND ANSWERS

- Q1.** Please refer to Amendment 5, Question and Answer 1, Mandatory Requirement M2, 2.2.1 where it states: "Must have a university degree (in any field)". Refer also to Amendment 5, Question and Answer 1, Mandatory Requirement 2.3.1 where it states: "Must have a university degree (in any field) or a college diploma (in any field)".

Based on this answer, candidates who are currently employed as Junior ID's who possess a college diploma would be restricted from advancing into the Intermediate level as they would not possess a university degree, even though they have gained or possess the requisite experience.

It is recommended that the response to Q&A1 of Amendment 5, Mandatory Requirement 2.2.1, be revised to allow this progression. In order to do so, please modify Mandatory Requirement 2.2.1 to read "Must have a university degree (in any field) or a college diploma (in any field)".

- A1.** Annex D to Solicitation # W8486-163123/A is amended as follows:

Mandatory Requirement M2, 2.2.1 is amended to read: "Must have a university degree (in any field) or a college diploma (in any field) with a minimum of three (3) years' experience as a Junior ID working within an ALSC contract."

- Q2.** Please refer to Annex "D" Technical Evaluation Criteria, M5, E-Learning Product Programmers (ELPPs), 5.3 Junior ELPP, 5.3.2 where it states: "Must have a minimum of two (2) years' experience in the last three (3) years in programming eLearning applications using Adobe Flash".

It is the bidder's experience that individual's who attend the Applied Studies Internship (ASI) program, may not obtain immediate employment making it difficult to possess two (2) years of experience within the last three (3) years. Therefore, we respectfully request that the three (3) year window be changed to five (5) years.

- A2.** Annex D to Solicitation #W8486-163123/A is amended as follows:

Technical Evaluation Criteria, M5, E-Learning Product Programmers (ELPPs), 5.3 Junior ELPP, 5.3.2 is amended to read: "Must have a minimum of two (2) years' experience in the last four (4) years in programming eLearning applications using Adobe Flash".

- Q3.** Please refer to Annex "D" – Technical Evaluation Criteria, Mandatory Requirements, M2, 2.2 Intermediate ID, 2.2.3 where it states: "Must have a minimum of three (3) years' experience in the last ten (10) years as a project lead instructional designer in the instructional design of eLearning product(s)".

We request that this mandatory requirement be modified to be project based rather than years of experience as follows:

Must have experience as a project lead Instructional Designer on a minimum of 1 project in the instructional design of eLearning product(s).

- A3.** DND's requirement remains unchanged.

- Q4.** Please refer to Annex "D" – Technical Evaluation Criteria, Mandatory Requirements, M5, 5.2 Intermediate ELPP, 5.2.3 where it states: "Must have a minimum of two (2) years' experience in the last five (5) years as project lead developer in the production of eLearning".

We request that this mandatory requirement be modified to be project based rather than years of experience as follows:

Must have experience as a project lead developer on a minimum of 1 project in the production of eLearning.

- A4.** DND's requirement remains unchanged.
