

It will be sent "prepaid" and is to be returned "prepaid".

The viewing sample shall be returned to the RCMP in the same condition as received by the manufacturer. Lost or damaged viewing samples shall be replaced by an identical item or the RCMP shall be reimbursed for the cost of an acceptable replacement.

SPECIFICATION

SOCKS, HEAVY WEIGHT, BLUE

1. **Definition**

- 1.1 This specification shall govern the manufacture and inspection of Socks, Heavy Weight, Blue. The specific item covered under this specification with stock number is as follows:
 - i. 6450 Socks, Heavy Weight, Blue / Chaussettes épaisses bleues.
- 1.2 This specification, viewing sample, drawing or other information issued in connection therewith, may only be used for specific enquiries, solicitations, or orders placed on behalf of the Royal Canadian Mounted Police.
- 1.3 This specification supersedes all previous specifications for Socks, Heavy Weight, Blue.
- 1.4 This specification has been translated into French from this original English language document.

2. <u>Applicable Specifications</u>

- 2.1 The following publications are applicable to this specification and to the issues in effect on the date of the solicitation, unless otherwise specified.
- 2.2 CAN/CGSB 4.2 Textile Test Methods; 14-2005, 19.1-2004 (R2013), 22-2004 (R2013), 23-M90 (R2013).
- 2.3 ISO, International Standards Organization Textile Test methods; ISO 105-C01, ISO 105-E-04.
- 2.4 CAN/CGSB 86.1-2003 Care Labelling of Textiles

3. General Requirements

3.1 The article or material covered by this specification shall be free from material and manufacturing defects that may affect its appearance or serviceability. In all

particulars not covered by this specification or contract documents, production shall be equivalent in all respects to the viewing sample.

3.2 **Design** - Socks, Heavy Weight, Blue to this specification shall be designed in accordance with the drawing attached and forming part of this part of this specification, and the viewing sample.

4. **Detail Requirements**

4.1 <u>Components</u>

- 4.1.1 <u>Yarn</u> The yarn shall be a blend of 29 micron spun wool nylon and spandex. There shall be not less than 68% or more than 80% wool. There shall be not less than 20% or more than 30% nylon and not less than 1% or more than 4% spandex. The yarn shall be dyed in dark navy blue, meeting the requirements outlined in Table I. The yarn shall be pre-washed and pre-shrunk as per good commercial practice.
- 4.2 **<u>Dimensions</u>** Socks, Heavy Weight, Blue to this specification shall be made to the dimensions given in the scale of measurements and the viewing sample.

4.3 <u>Construction</u>

- 4.3.1 <u>Knitting</u> Cuff, leg and top of foot shall be 3x1 rib. The sole shall be plain knit. There shall be spandex yarn woven into top 6 cm of the cuff.
- 4.3.2 <u>Machine</u> The machine shall be a circular machine 13 cm, in diameter, 68 to 84 needles.
- 4.3.3 <u>**Closing</u>** The toes shall be closed by auto flat seam or on a merrow sewing machine. Closing thread colour is to match sock colour.</u>
- 4.3.4 <u>Marking</u> Each pair of socks shall be legibly marked in accordance with good commercial practice, with the following information in English and French:
 - 1. Manufacturer's Identification
 - 2. Size
 - 3. RCMP Stock Number (6450-000)
 - 4. Date of Manufacture, in numeric format year/month (Ex. 2001/11)
- 4.3.5 <u>**Cleaning Instructions Label</u>** The label shall be completed in accordance with the following information in English and French. The use of cleaning symbols is acceptable as replacement to text as shown below.</u>

Machine wash - cold (30°C)	Laver à la machine – à l'eau froide (30°C)	$\overline{}$

Note: The manufacturers identification shall not appear anywhere on the garment except on the garment label as indicated.

5. **Quality Assurance Provisions**

- 5.1 <u>**Responsibility for Inspection**</u> Unless otherwise stipulated in the contract, it is the prime contractor's responsibility to satisfy the R.C.M.P., Uniform & Equipment Program that the material and services being supplied conform to this specification. This may be accomplished by performing the tests specified in this specification or by demonstrating to the satisfaction of the R.C.M.P., Uniform & Equipment Program that conformity to this specification of manufacturing processes is assured. The contractor may use any commercial testing establishment acceptable to the R.C.M.P., Uniform & Equipment Program.
- 5.2 The R.C.M.P., Uniform & Equipment Program reserves the right to perform any inspection considered necessary to ensure the material and services conform to the specified requirements. For the purpose of inspection, a portion of each delivery not exceeding two percent or two out of any number delivered under 100 may be put to tests that could destroy the articles. If found to be inferior or not in accordance with this specification, all articles so destroyed shall be replaced by others of proper quality and pattern at the expense of the contractor. The entire delivery may also be rejected if it is found that articles previously rejected due to non-repairable defects are redelivered for inspection.
- 5.3 The contractor will be promptly notified when any articles are not accepted and such articles will be returned at the contractor's risk and expense.


