BIDDERS' QUESTIONS AND CANADA'S RESPONSES

- Q1. Do you have any installation drawings, the spec states to remove asbestos containing bulkhead panels, install new portholes and install new non asbestos panels? Is there a drawing showing the area to be removed (extent of removal). List of interference items etc?
- A1. We do not have any clear drawings showing those details. Bidders are encouraged to view the cabin during the site visit.
1. The drawing, **B-10-1372-005 VLE Phase 2 Accommodation Insulation Plan.pdf**, already provided only shows details of new insulation fitted in 2010. Asbestos containing insulation on the forward bulkhead of this cabin was not removed in 2010. The forward bulkheads are covered with original marinate panels from ship construction in 1969.
 2. The marinate panel cannot be cut as the risk is too high. The entire panel in the way of the portlights must be removed and the Contractor must propose a new panel to be fitted in its place.
 3. **The following additional drawings and information are available for reference.** To obtain these documents the Bidder must make a request in writing to the Contracting Authority identified in Article 7-5.1.
 - 4 drawings from original construction
 - Scanned pages from the last two asbestos surveys that refer to this cabin. The one from 2010 has the most detail and shows that we are dealing with Marinate panel that contains Chrysolite and Amosite.
 - Photo of the existing portlight, senior engineer cabin
- Q2. The PDS requests a price in line 2 for drawing production. It is not clear what drawings the bidders should price for this line item. If a particular section of the specification requires drawings to be produced, the costs for those drawings should be incorporated in that section of the PDS (for example, 12.1.B.2.1) rather than a lump sum line item for the entire project. Can the PDS be revised to reflect drawing costs in relevant sections of the PDS?

A2. Drawings are required for the following specification items only:

1. 12.1.B.2.1 and 12.1.D.4.1 – Bowthruster Control Upgrade – Siemens as-fitted drawings are required. These drawings must follow the CCG National CAD Standards format.
2. 14.1.B.2.1 and 12.2.D.4.1 – Derrick Control PLC Upgrade – JC Controls must provide final as-fitted drawings. These drawings must be in the same format as the preliminary drawings provided. The reason for this is that they are revisions of original drawings and will retain the same drawing numbers.

The PDS has been revised. To obtain this document the Bidder must make a request in writing to the Contracting Authority identified in Article 7-5.1.

Q3. G1.6.3 of the specification references the Canadian Coast Guard National CAD Standards “Computer Aided Design (CAD) using AUTOCAD”. Please provide a copy of this reference document.

A3. Document is available. To obtain this document the Bidder must make a request in writing to the Contracting Authority identified in Article 7-5.1.

Q4. Is the annual aggregate of \$20,000,000.00 a new clause? Please clarify.

A4. No. This is the same clause that has been in use for the past 10 years. Please refer to page 19, Article 7-2.1.3.2 of the ITT.

Q5. Who is responsible for the warranty on the sub-contractors goods/service? (Example MAN Diesel & Turbo work on the engines)

A5. The prime Contractor is responsible for the warranty. Refer to page 18, and 19 Article 7-2.1. in the ITT.

Q6. Can a progress payment be done for May and June?

A6. Yes. Progress payments can be done once a month.

Q7. If the employee is working 12 hour shifts how do we charge for overtime beyond this time?

A7. The length of a shift in the Contract is 12 hours. Any work beyond 12 hours will be paid as overtime.
