Amendment 003 is raised to answer questions below:

Questions:

1. Drawing 9240121 – Left end panel view shows what seems to be a string / cord, and again on section F-F, evidence of cord as part of item 3.
Drawing 9240115 (Item 3) has no evidence of that cord on the drawing or in the materials list.
What is the material the cord is made of and what are the dimensions?
2. The drawing calls for 3M part number 8960 – Tape, Reflective, 2" Wide (white), which has been discontinued without replacement. We would like to suggest replacing this with 3M product 8925 which is a 2" reflective tape (silver). Please advise if this replacement can be made; and if not which product should be used instead.
3. The 45 Ligne button 389556 called out on drawing 9240112 indicates an 8mm slot. Would it be acceptable to use a 45 Ligne button with an 11mm slot, and use D-80-001-151/SF-001 poly webbing of the same width to attach to the panel?
4. The 45 Ligne button 389556 called out on drawing 9240112 calls for white. However, the NSN for the button itself indicates that it is a green button.
Our supplier has indicated a 50,000 pc minimum for the white. Can we use Canadian average green (which has no minimum) instead of white? If green is not acceptable, could the white be supplied as GSM for the contract?

Answers:

1. A suggestion is required from the company in regards to question 1, much like question 2 which has a solution and I agree with how they would like to move forward.
2. The 3M replacement is no issue, definitely move forward with the replacement.
3. Yes.
4. I believe the bag is orange, for that reason we need the buttons to be white. We have moved away from green due to visibility in a crash scenario. Whatever direction that makes attaining white buttons the easiest I will support.

All other terms and conditions remain unchanged.
