## **Amendment 002**

Amendment 002 is raised to answer the following Industry Questions:

**Question 001:** *To include the cost of bonds in the submission we will need to know the % required for the Labour and Material Bond and the Performance Bond. Could you kindly advise?*

**Response 001:** There are two types of security required, (1) Bid Security and (2) Contract Security.

1. For Bid Security required at the time of bidding please refer to *General Instructions- Construction Services- Bid Security Requirements (2016-04-04) R2710T, Clause GI08 Bid Security Requirements.*
  - As per GI08, Article 1, "The Bidder shall submit bid security with the bid in the form of a bid bond or a security deposit in an amount that is equal to not less than 10 percent of the bid amount. Applicable Taxes shall not be included when calculating the amount of any bid security that may be required. The maximum amount of bid security required with any bid is \$2,000,000."
2. For Contract Security required at contract award please refer to *General Condition GC9- Contract Security (2014-06-26) R2890D, Clause GC9.1 and GC9.2.*
  - As per GC 9.2, "The Contractor shall deliver to Canada either (a) or (b).
    - a. A performance bond and a labour and material payment bond each in an amount that is equal to not less than 50 percent of the Contract Amount (excluding applicable tax(es)).
    - b. A security deposit or an irrevocable standby letter of credit in an amount that is equal to not less than 20 percent of the Contract Amount (excluding applicable tax(es))."

**Question 002:** *Please confirm the design status of the packages at this point.*

**Response 002:** By the time of contract award, most packages will be at advance 90% completion. The intention is to have input and comments from the CM to finalize the design to 100%.

---

**Question 003:** *Please confirm the amount, per week, of the meeting that will occur with the consultants.*

**Response 003:** Bi-weekly meeting will be required for the CM and the design consultants.

---

**Question 004:** *What is driving the work packages project assembly? Could we rearrange the project in different work packages?*

**Response 004:** CM will not be expected to complete tasks by the packages but rather by individual sub-projects. i.e. sub-contract tendering and award will be for each sub-project. CM will not be expected to engage the same sub-contractors for the entire package, but rather for each individual sub-project.

**Question 005:** *Most of the project seems to require shutdown period on critical systems. Is the intent to organize major plant shutdown to expedite most of the projects at the same time, or*
