### **Solicitation Amendment No. 003**

This solicitation is hereby amended to provide the following questions and answers:

**Q11. Item 1.13 - There are 3 enclosures. Are there 18 each 3-pole terminal blocks per enclosure, or are there 18 divided between 3 enclosures?**

A11. Item 1.13 - The 18 3-pole terminal blocks are divided between three enclosures.

**Q12. Item 2.2 - You are asking for 34 enclosures 8"x12"x4" along with 34 and 16 power distribution blocks. Should these three items be requested as three separate line items as there is no way you could put all these distribution blocks in one of these enclosures? Please confirm.**

A12. Item 2.2 - The 34 terminal blocks plus the 16 terminal blocks are divided between 34 enclosures.
