1. QUESTION

This addendum did clarify a couple of my original questions with regards to size and grade, however it did not specify the finish on the material. Is it to be plain steel, galvanized, etc.

ANSWER

Ungalvanized rods are required.

2. QUESTION

Please clarify the extent of the removals along the sheet pile and rock face at Graham's Pond. (I.e. Is any sheet pile being removed?).

By my site measurements taken last week to build the required length of wharf as per the tender documents, some sheet pile would need to be removed. Please provide confirmation.

ANSWER

Reference Detail 1/M2, Dwg M2of3: Work in the area of Pile Lines 15 to 19 may contain existing steel sheet piling (SSP) and backfills/gravels not indicated on this drawing.

Bidders are advised it will be necessary to remove existing SSP and backfills/gravels as may be required to construct the full indicated length and framed pile bents of structure as shown on the detail.

Costs for this removal to be as per the indications of the Unit Price Table and Section 01 74 21, Par. 1.3; which is amended as follows:

Section 01 74 21; Paragraph 1.3 - Measurement Procedures

INSERT - Par 1.3.3 - The construction materials noted in 1.3.1.1, 1.3.1.2 and 1.3.1.3 as well as 1.3.2 above, shall include existing steel sheet piling to be extracted and backfill materials to be removed and disposed on-site. Extracted SSP to become property of the Contractor.
