2. Subcontracts which contain security requirements are NOT to be awarded without the prior written permission of PCASD.

\*\* Security Requirements Check List was added as an attachment on Buy & Sell. Must be completed by all personnel who will be working on the project.

Contractor must complete Sections B & C (initial 1+2) of 330-23 form. The forms can be sent after contract is awarded. However work cannot begin until the necessary personnel clearance is achieved. Processing should take 48hrs.
