SCOPE OF WORK / DELIVERABLES:

The scope of work consists of the furnishing of all plant, labour, equipment and material for this paving and other associated works at DFO storage are on 440- 450 Southside Road, St. John's, NL. The project is to be completed in strict accordance with the specification and accompanying drawings, and subject to all terms and conditions of the Contract.

In general, work under this contract consists of, but will not necessary be limited to, the following:

- 1. Re-grading (and scarifying where necessary) of the existing granulars and backfill, to ensure positive site drainage. Development of the grading plan is the responsibility of the Contractor, to the approval of the Departmental Representative.
- 2. Supply and installation of additional granulars, where necessary, and paving of the existing storage area, as noted on the drawings. Quantity estimates are provided on the drawings.
- 3. Supply and installation of three (3) signs, as noted on the drawings.
- 4. Extension of an existing groundwater monitoring well, as noted on the drawings.

FAMILIARIZATION WITH SITE:

Site visit will be only allowed if given proper permission. In order to get site visit permission, please contact directly and only by email the Senior Contracting Officer listed below.

Before submitting a bid, bidders can visit the site and its surroundings, at their own expense, to review and verify the form, nature, and extent of the work, materials needed for the completion of the work, the means of access to the site, severity, exposure, and uncertainty of weather, soil conditions, any accommodations they may require, and in general shall obtain all necessary information as to risks, contingencies, and other circumstances which may influence or affect their bid. No allowance shall be made subsequently in this connection on account or error or negligence to properly observe and determine the conditions that will apply.

Contractors, bidders, or those they invite to site are to review specification Section 01 35 28 – "Health and Safety Requirements" before visiting site. Take all appropriate safety measures for any visit to site, either before or after acceptance of bid.
