(1) SUBMISSION REQUIREMENTS AND EVALUATION (SRE) REVISION

SRE 3.2.3 Achievements of Key Personnel on Projects

Delete: In its entirety

Insert: Describe the experience and performance of key personnel for Architect, Structural, Mechanical, and Electrical Engineer as identified in SRE3.1.2 Consultant Team Identification, to be assigned to this project regardless of their past association with the current proponent firm. This is the opportunity to emphasize the strengths of the individuals on the team, to recognize their past responsibilities, commitments and achievements.

Information that should be supplied for each key personnel:

- **Names of key personnel for Architect, Structural, Mechanical, and Electrical Engineer, as identified in SRE 3.1.2 Consultant Tea Identification, responsible for project delivery and Curriculum Vitae (CV)**
- **Professional accreditation**
- **Accomplishments/achievements/awards**
- **Relevant experience, expertise, number of years experience**
- **Role, responsibility and degree of involvement of individual in past projects**

(2) REQUESTS FOR CLARIFICATION

Question 1: Could you please forward the security application to the appropriate department. I have repeatedly try to send it the email address noted on the web site with continued bounce back. We are not aware of the process for the security clearance.

Answer: Public Works and Government Services Canada (PWGSC), Ontario Region Security Division can be the sponsor and submit a Private Sector Organizational Screening for prospective proponents, who are not already registered with CISD at the security level required. Question 2: Is there an absolute need for the consultant to have a valid DESIGNATED ORGANIZATION SCREENING to execute this project. The Security Requirements Check List would suggest there may not be a need for this level of security.

Answer: Please refer to SI 6 Security Requirement:

1. At the date of bid closing, the following conditions must be met:
 - (a) the Proponent must hold a valid organization security clearance as indicated in Supplementary Conditions SC1;
 - (b) the Proponent's proposed individuals requiring access to classified or protected information, assets or sensitive work site(s) must meet the security requirement as indicated in Supplementary Conditions SC1;
 - (c) the Proponent must provide the name of all individuals who will require access to classified or protected information, assets or sensitive work sites.

Question 3: Does PWGSC expect that resumes for each of the 16 Proponent and the Key sub-consultants identified in section SRE 3.1.2 are to be provided in SRE 3.2.3?

Given the information that is required for each individual listed in 3.2.3 and the "Requirement for Proposal Format" in SRE 2.1, are these 16 resumes to be included in the 30-page limit PWGSC has given the Proponent?

Answer: Proponent must provide the experience and performance of key personnel for Architect, Structural, Mechanical, and Electrical Engineer. A resume from each of the sub-consultants is not expected.

Resumes of Key Personnel provided under 3.2.3 are to be included in the 30-page limit.

All other terms and conditions of the solicitation remains the same.
