1. **THE BID CLOSING DATE WILL BE EXTENDED TO :**

THURSDAY MAY 31, 2016 – 14H (HAE).

2. In section **BID AND ACCEPTANCE FORM (BA)**;

The Contractor shall perform and complete the Work from **June 6th to October 31 st, 2016*** from the date of notification of acceptance of the offer.

Work on the **dock C** on site start : October 3rd, 2016

Work on the **dock B** on site start : October 11, 2016

***Water interventions shall be executed between August 1st and March 31st outside the sensitive period to insure protection of aquatic species, water works shall be minimized during the allowed period.**

By reason of the Nautical Fest which will take place on the site in July 2016, the contractor cannot carry out surveys or work on the site during July 6 to July 13, 2016 inclusively.
