Contractor to include all necessary drain valves and vent valves to accommodate this and be able to demonstrate the process during final commissioning or handover.”

“Note 2: Provide drain and vent valves, as many as required, to facilitate winter shut down as noted in note 1.”

.3 Mechanical Drawing M-2 Existing and New Floor Plan Building #32, #34, & #38
– Propane & Ventilation Layout;

1. Delete reference to CO2 valve, and provide propane shut off valve.

2. New Propane Notes to be revised as follows:

“Note 1: Propane Contractor shall install two 420lb cylinders on a concrete pad as shown c/w high pressure regulator and associated piping. Cylinders to be supplied by Propane Utility in coordination with the owner/ TN Park.”

3. New Ventilation Notes to be revised as follows:

“Note 1: Existing Fans, Ductwork, & Wall Cap c/w Birdscreen to be replaced. Thermally insulate rigid ductwork. Paint wall cap to match final siding color. New Fans to be equal to F-1 as indicated on M-3.”

“Note 2: Existing Fans, Ductwork, & Wall Cap c/w Birdscreen to be replaced. Thermally insulate rigid ductwork. Paint wall cap to match final siding color. New Fans to be equal to F-1 as indicated on M-3.”

.3 Reference Mechanical Drawing M-3 Plumbing Schedules and Details

.4 Reference Mechanical Drawing M-5 Plumbing Schedules and Details

.1 Delete detail 2/M-5. Propane piping shall be ran above grade to building c/w adequate support and blocking to fully secure piping.

.5 Reference Electrical Drawings

.1 In EACH building, Electrical contractor to supply and install one each 120V, 15A circuit c/w breaker and wiring in conduit to provide power to the controls transformer that services the shower control valves. Controls transformer to be located in the service room or similar location. Coordinate with the Mechanical Trade onsite.
