1.2 **ADD** hatched area corresponding to the note for “Denotes Approx. Location of Owner Reported Wet Wall” to the east wall of the “Evaporator” room, at the intersection of gridlines 6 and E. Hatched area is to match thickness of exterior wall. Extend hatch approximately 2100mm north along gridline E and 2100mm south along gridline E from the intersection at gridlines 6 and E, consistent with the scale of the drawing.

**2.0 RESPONSE TO CONTRACTOR QUERIES:**

Q #1: On Clause 1.01.2.3 of Section 01 11 55 says that “use of power tools is not permitted for paint removal” but on Section 09 91 00 Painting; Clause 3.2.3 says that “surface prep for painting by abrasive blast”. Please confirm abrasive blasting will be permitted or not?

**A #1: Abrasive blast surface preparation will be permitted on metal items, in conformance with applicable MPI guidelines.**

Q #2: Will the Environmental Consultant Fee be carried in the Contractor Price or by Public Works and Government Services Canada?

**A #2: The Environmental Consultant will be hired by Public Works and Government Services Canada.**
