All bids bonds are to be submitted in hard copy by the bid closing date and time to the mailing address indicated above.

Any tender received after the above noted time will be considered late and will be returned to the sender unopened. Tenders may be revised by email, provided the render and revision(s) are both received prior to Tender Closing Time.

SCOPE OF WORK / DELIVERABLES:

The scope of work consists of the furnishing of all plant, labour, equipment and material for this reconstruction at Little Port, NL. The project is to be completed in strict accordance with the specification and accompanying drawings, and subject to all terms and conditions of the Contract.

In general, work under this contract consists of, but will not necessary be limited to, the following:

1. Demolition and removal of a portion of the existing wharf, in the area noted on the drawings;
2. Temporary shoring measures to protect the adjacent slipways during wharf removal and reconstruction;
3. Construction of a new treated timber crib wharf, complete with reinforced concrete deck, to the dimensions as indicated on the drawings;
4. Supply and installation of mooring cleats, structural timber for coping, wheelguard, wheelguard blocking, fenders, ladders and associated hardware for new wharf construction;
5. Salvage Disposal and removal of existing the existing electrical shed;
6. Supply and installation of a new electrical shed. Salvage the existing electrical components and install in new shed location (carryall costs to extend any existing conduits). Demolish and dispose of existing shed;
7. Uplands rock and gravel fill placement, topped with granulars and asphalt, as noted on the drawings;

LOCATION OF WORK, WORK SITE AND DELIVERY POINT:

Little Port, NL

FAMILIARIZATION WITH SITE:

Before submitting a bid, bidders can visit the site and its surroundings, at their own expense, to review and verify the form, nature, and extent of the work, materials needed for the completion of the work, the means of access to the site, severity, exposure, and uncertainty of weather, soil conditions, any accommodations they may require, and in general shall obtain all necessary information as to risks, contingencies, and other circumstances which may influence or affect their bid. No allowance shall be made subsequently in this connection on account or error or negligence to properly observe and determine the conditions that will apply.



Contractors, bidders, or those they invite to site are to review specification Section 01 35 28 – “Health and Safety Requirements” before visiting site. Take all appropriate safety measures for any visit to site, either before or after acceptance of bid.

MANDATORY REQUIREMENTS:

Under these circumstances, the Tender and **original signed Bid Bond** must be delivered to the Closing Location prior to the closing date.
