This Amendment No. 003 is raised to amend Solicitation EW699-162676/A as follows:

1. In **ANNEX "C" – TECHNICAL, MANAGEMENT AND INUIT BENEFITS CRITERIA EVALUATION**, following the table titled 2.0 Management and Organization Proposal:

DELETE: Section III: Inuit Benefits Criteria

INSERT: Section II: Inuit Benefits Criteria

This Amendment is also raised to answer the following questions:

Q1: Can PWGSC name the Contractor?

A1: All information required has been provided on the Buyandsell website. The name of the Contractor is not required at this time.

Q2: Is the contractor to provide a soil lab facility for the Departmental Representative staff? If so, is the contractor also responsible for supplying soil testing equipment and outfitting the soil lab?

A2: No, the contractor will not be providing a soil lab facility for the Departmental Representative staff.

Q3: Where does the contractor provide flights from for the Departmental Representative and staff?

A3: The contractor will be providing flights for the Departmental Representative and Departmental Representative's Authorized Personnel from Qikiqtarjuaq, NU to site and back.

Q4: Is the contractor able to accommodate additional personnel for the Departmental Representative staff if required during high activity periods on site?

A4: The contractor is required to provide one bed for the Departmental Representative, and two additional beds for Departmental Representative support personnel and Crown visitors.

Q5: Are ATVs and/or pick-up trucks to be provided by the contractor for use by engineering staff?

A5: The contractor will provide two, two-passenger ATVs for exclusive Departmental Representative use.

Q6: Can an extension to the closing date be provided?

A6: No extension to the closing date will be provided.

Q7: On page 7 of the RFP, the Inuit Benefits Plan is cited as **Section II**. On page 24 of the RFP, the Inuit Benefits Plan is cited as **Section III**. Please clarify.

A7: Please refer to Amendment above.

Q8: In the RFP document pages 10/11, what is the difference between **5.1.1 Integrity Provisions – Declaration of Convicted Offences**, which is required with the bid, and **5.2.1 Integrity Provisions – Required Documentation**, which is required precedent to contract award?

A8: **5.1.1 Integrity Provisions – Declaration of Convicted Offenses** is required with the bid if an Integrity Declaration Form must be submitted. An Integrity Declaration Form must be submitted **only** when:

1. the supplier, one of its affiliates^{Footnote 1} or a proposed first-tier subcontractor^{Footnote 2} has been charged with or convicted of a criminal offence in a country other than Canada that, to the best of the supplier's knowledge and belief, may be similar to one of the listed offences in the [Ineligibility and Suspension Policy](#) (the "Policy"); and/or
2. the supplier is unable to provide any of the certifications required by the [Integrity Clauses](#).

5.2.1 Integrity Provisions – Required Documentation refers to Part 17 of the Ineligibility and Suspension Policy:

List of names: All suppliers, regardless of their status under the Policy, must submit the following information when participating in a procurement process or real property transaction:

- suppliers that are corporate entities, including those bidding as joint ventures, must provide a complete list of the names of all current directors or, for a privately owned corporation, the names of the owners of the corporation;
- suppliers bidding as sole proprietors, including sole proprietors bidding as joint ventures, must provide a complete list of the names of all owners; or
- suppliers that are a partnership do not need to provide a list of names.
