Q1: Are the bids evaluated based on the combined price of the Base Work and the Optional Work, even though the Optional Work may not be awarded?

A1: Yes.

Q2: Can the Contractor charge for the mobilization, demobilization, and site facilities provision line items in the Optional Work if the Optional Work is continuous with the Base Work and no mobilization, demobilization, or new site facilities are incurred?

A2: No.

Q3: Is it possible that a portion of the Optional Work would be completed this year and the balance completed next year (with a break in between)?

A3: Yes.

Q4: Does the Sep 15 date referred to in the Specifications (eg Section 01 32 16.07 1.6.2) apply only to the Base Work and not the Optional Work?

A4: Yes.

Q5: Does the Unit Price item for addressing Hazardous Building Material (HBM) Concerns apply only to HBM identified in the Appended reports?

A5: Yes. If additional HBM are encountered that must be addressed as part of the building move then these would be subject to a Change Order. Note that the intent is not to remove all HBM.

Q6: Is the Contractor responsible for removing and moving the unattached contents of the Maintenance Garage?

A6: No. All loose tools, equipment, and furniture will be removed by others prior to the work commencing. Note that fixtures, siding, insulation, and the door and associated mechanism are part of the move.

Q7: The oil-water separator at the new Maintenance Garage is not shown on the drawings; is it the responsibility of the Contractor to design and place this?

A7: Yes.

Q8: Is the backfilling for the new location of the Maintenance Garage to be brought up to existing grade?

A8: Yes.

Q9: There are several sources of backfill; where are they and will they be placed in any specific order?

A10: The location of the available backfill will be provided by the Departmental Representative and the Departmental Representative will determine the order in which the backfill is to be placed.

Q11: Are there known places to patch the biocell?

A11: No, the biocell patches are to be made available as a contingency.

Q12: Does the biocell need preparation work.

A12: Yes. In addition to patching any holes discovered, the bedding sand needs to be levelled and covered with plywood prior to placing contaminated soil.

Q13: What is the thickness of the biocell liner that may need to be patched?

A13: the liner is 40 mil.

Q14: Is there presently any contaminated soil in the biocell?

A14: No, there is no contaminated soil in the biocell prior to work. Currently there is approximately 30 cm of bedding material on top of the liner.

Q15: Will the AST tanks being moved in line item 11 be emptied by the owner prior to moving?

A15: Yes, the tanks will be emptied before the contractor has to move them.

On page 4 of 28 in the Invitation To Tender document, under Article SI04 – MANDATORY SITE VISIT;

DELETE: Bidders who have not signed the attendance sheet will not considered non-compliant.

INSERT: **Bidders who have not signed the attendance sheet will be considered non-compliant.**

All other terms and conditions remain unchanged.
