This Amendment No. 4 is issued to amend the solicitation as follows:

1. In the Statement of Work at ANNEX A, at **4.0 POTENTIAL ADDITIONAL WORK:**

DELETE: The following work is not included in the current scope of work. However, should, during the course of the remediation activities, additional required remediation work be discovered, the following activities may be required from the Consultant.

INSERT: Potential Additional Work may include a range of engineering and consulting services in support of the remediation activities to be completed at the FOX-D site. The following work is not included in the current scope of work. Potential Additional Work may include (but is not limited to) the following tasks.

INSERT: 4.4 Environmental Assessment

1. Environmental Assessments include the re-interpretation of Phase III Environmental Site Assessment (ESA) raw data, collection and analysis of additional samples to confirm and refine volumes of impacted soil, and identification of any previously unknown or unidentified hazardous materials found on site (liquids or solids).
2. Environmental Assessments could be used, for example, to verify soil volumes as identified in the specifications, or to determine and refine the estimate of impacted soil to be excavated from buried debris areas, or to determine handling and disposal methodology for previously unknown or unidentified hazardous materials found on site.
3. Environmental Assessments may involve, but are not limited to, collection and analysis of additional samples, comparison of sample results to AMSRP or other applicable criteria, and recommendations on handling, treatment and disposal of each waste stream.
4. The assessments would require a written memo report documenting the results and recommendations, including figures of sample locations.

ANNEX "J" HEALTH AND SAFETY REQUIREMENTS

1. Workers Compensation

1. The recommended Proponent shall provide to the Contracting Authority, prior to Contract award:
 - a) a Workers Compensation Board letter of good standing, also listing covered Directors, Principals, Proprietor(s) or Partners who will be or who are anticipated to be present on the work site(s).
2. The recommended Proponent shall deliver all of the above documents to the Contracting Authority on or before the date stated (usually 3-5 days after notification) by the Contracting Authority. Failure to comply with the request may result in the proposal being declared non-compliant.

2. Employer/Prime Consultant:

1. During the Construction Stage
 - a) The Consultant shall, for the purposes of the Occupational Health & Safety Acts and Regulations, and for the duration of the Work of the Contract, agree to accept that the Construction Contractor is the Principal/Prime Contractor, and to conform to that Contractor's Site Specific Health and Safety Plan.

This amendment is also raised to answer the following:

Q1: The Evaluation criteria (1.3) asks bidders to identify the Engineer of Record. The definition of "The Consultant" in the Terms of Reference (Section 1.2) indicates that the Consultant is to be Engineer of Record. Based on professional guidelines and responsibilities, this would be a separate scope of work as the majority of the bidders for this project were not involved with the design. Should all bidders include sufficient scope to professionally undertake this role for the FOX-D project?

A1: The Consultant awarded this contract would be the Engineer of Record for the implementation of this design, while Dillon would remain Engineer of Record for the actual design.

Q2: Will the Consultant's role include Owner's Engineer?

A2: See answer to Q1.

Q3: Is the consultant responsible for providing the soil lab facility? If so, do these costs need to be included in the disbursements, and will the Contractor provide transportation for the lab to site and cover costs?

A3: The consultant is not responsible for providing a soil lab facility – if required, this will be provided by the remediation contractor, currently planned for an off-site location.
