RFSA for Workspaces – Category 6

Note to Suppliers:

With respect to the submission deadline for the Product Catalogue for Category 6, suppliers are to take note of the following.

- a) PSPC intends to respond to questions received after May 19, 2016 and before June 9, 2016. Any suggested modifications to the products, specifications or product dimensions received after May 19, 2016 have a lower likelihood of being considered.
- b) PSPC intends to provide consideration to suppliers who are unable to submit a complete bid on or before June 9, 2016. The process for doing so is undetermined at this point, but it may involve an early modification opportunity, the submission of a modified catalogue, an opportunity to submit on a new version of the catalogue, or any other method.
- c) Suppliers who need more time to complete the Product Catalogue for Category 6 can choose to submit their arrangement at a later date. Canada will strive to include new suppliers into the Supply Arrangement as they come in, and as quickly as limited resources allow us to complete the evaluation of their arrangement.

Please be aware that this note applies only to the June 9, 2016 inclusion of the new Product Category 6 into the Supply Arrangement for Workspaces.
